### Awards Banquet, Installation of Officers, and Cornhole Tournament

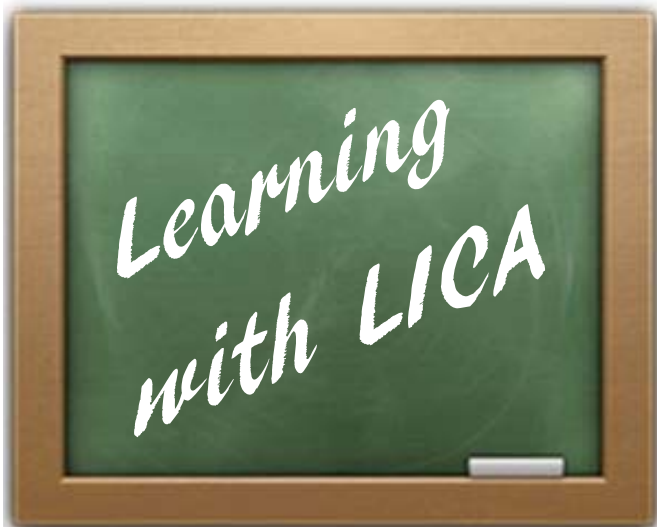
